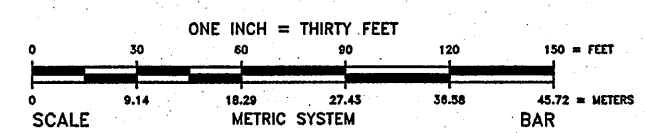
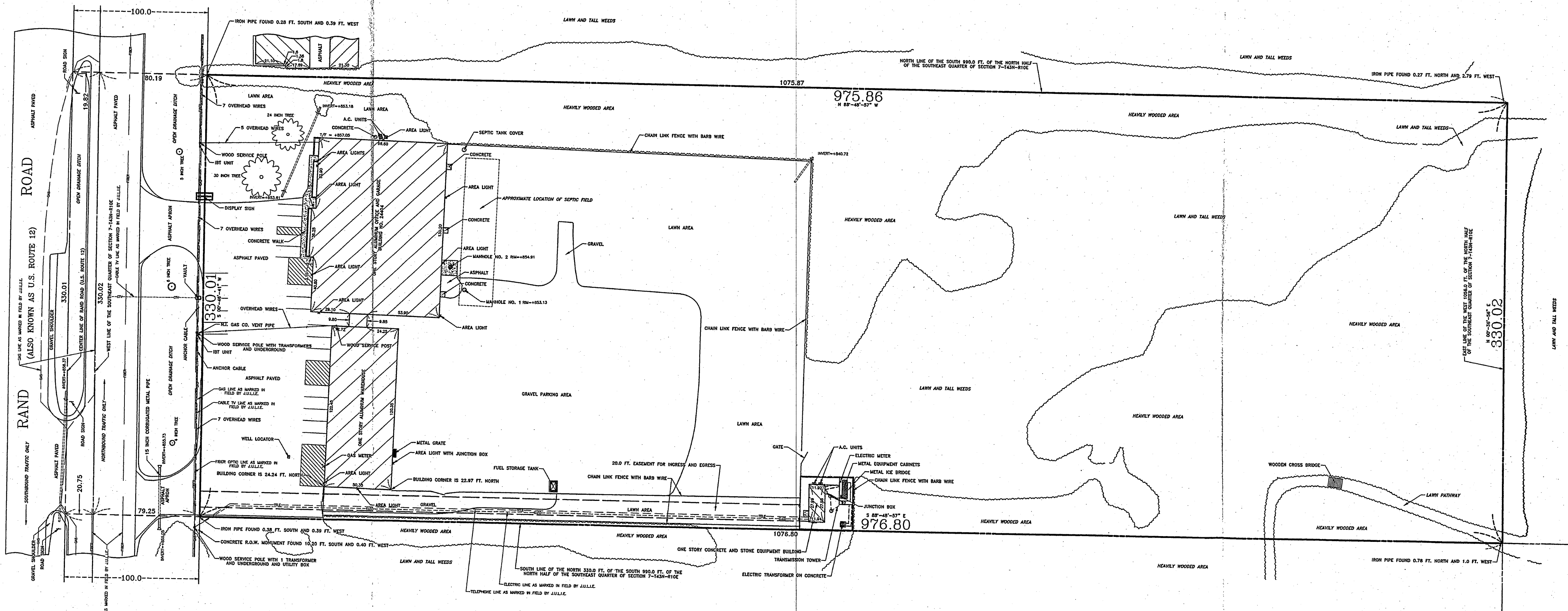


**PROPERTY DESCRIPTION**

OF THE NORTH HALF OF THE SOUTH EAST QUARTER OF SECTION SEVEN, TOWNSHIP FORTY-THREE NORTH, RANGE TEN, EAST OF THE THIRD PRINCIPAL MERIDIAN, EXCEPT THAT PART BEING USED FOR HIGHWAY PURPOSES AND DEDICATED FOR ILLINOIS STATE HIGHWAY ROUTE 12 (ALSO KNOWN AS RAND ROAD), ALL IN LAKE COUNTY, ILLINOIS.  
CONTAINING 322190 SQUARE FEET OR 7.397 ACRES, MORE OR LESS.
